Farm Tour Agreement

This Farm Tour Agreement ("Agreement") is entered into on the ____ day of _____, 20, between Harry Thuku Beverages LP ("the Company") and:

1. Purpose

The Company agrees to permit the Visitor to participate in a guided tour of the Company's farm, coffee processing facilities, livestock areas, and other designated locations subject to the terms of this Agreement.

2. Tour Safety Kit

Where appropriate, the Company shall provide or make available suitable safety equipment, which may include reflective vests, protective footwear, helmets, gloves, eye protection, face masks, or first aid supplies depending on the nature of the tour.

The Visitor agrees to properly wear and use any required safety equipment throughout the tour and to promptly report any damaged or defective equipment.

3. Compliance with Laws and Instructions

The Visitor agrees to comply with all applicable laws of the Republic of Kenya and all reasonable instructions issued by Company representatives during the tour.

The Visitor shall not engage in unlawful, dangerous, disruptive, or abusive conduct.

4. Restricted Areas

The Visitor shall enter only those areas designated by the tour guide.

Entry into machinery rooms, chemical storage areas, livestock handling facilities, water treatment systems, workshops, offices, or any restricted location without authorization is prohibited.

5. Protection of Company Property

The Visitor shall exercise reasonable care to protect the Company's buildings, machinery, crops, livestock, equipment, records, products, and other property.

The Visitor shall not intentionally damage, remove, alter, misuse, or interfere with Company property.

Where the Visitor negligently or intentionally causes damage, the Visitor may be responsible for the reasonable cost of repair or replacement as permitted by applicable law.

6. Photography and Recording

Photography and video recording are permitted only in areas approved by the Company.

The Visitor shall not photograph confidential business information, security systems, or restricted operations without prior written authorization.

7. Health and Medical Fitness

The Visitor confirms that they are reasonably fit to participate in the tour and will notify the Company of any medical condition that could reasonably affect their safety during the visit.

The Visitor agrees to follow all safety instructions and immediately report any illness, injury, or emergency.

8. Infrastructure and Environmental Risks

The Visitor acknowledges that agricultural operations may involve uneven ground, steep slopes, mud, dust, loose gravel, wet surfaces, livestock, insects, changing weather conditions, ongoing construction, and rural infrastructure that may not meet urban standards.

The Company shall take reasonable steps to identify hazards and conduct the tour safely. The Visitor agrees to exercise reasonable care, wear appropriate footwear and clothing, and follow all safety instructions while on the premises.

9. Emergency Procedures

The Visitor agrees to cooperate with Company personnel during emergencies and to follow evacuation or first aid instructions where necessary.

10. Compliance with Biosecurity Measures

The Visitor agrees to comply with any biosecurity requirements, including footwear sanitation, hand hygiene, movement restrictions, or other disease prevention measures implemented by the Company.

11. Personal Property

Visitors remain responsible for their personal belongings. The Company shall not be responsible for loss or damage except where required by applicable law.

12. Termination of Tour

The Company reserves the right to terminate the tour immediately where the Visitor fails to comply with this Agreement or creates an unreasonable risk to persons, animals, or property.

13. Governing Law

This Agreement shall be governed by the laws of the Republic of Kenya.

14. Entire Agreement

This Agreement constitutes the entire understanding between the parties regarding the farm tour.
